### Important! Read Before Signing:

1. I hereby acknowledge receiving the above-described animal. In consideration of receiving the above-described animal from NEVADA FRENCHIE RESCUE INC, I hereby agree to the following terms and conditions:
2. I agree to care for the Dog in a humane and responsible manner as a member of my family, and to assume full responsibility for the Dog's well being for the rest of its life. I agree to provide sufficient shelter for the Dog.
3. I agree to take the animal to a veterinary at my own expense should the animal become ill or injured. I agree to provide the Dog with a well-balanced diet, sufficient water and all necessary veterinary care including vaccinations and annual physical examinations. I understand that the cost of any veterinary care following adoption is entirely my responsibility. I also agree not to debark, crop, dock or otherwise surgically alter the Dog for any non-medically necessary purpose. I also agree not to transport this Dog in an open truck cargo area.
4. I agree to provide obedience training for my Dog in the event the Dog is under one year of age at the time of adoption, or in the event I encounter any behavior problems with the Dog, or in the event NEVADA FRENCHIE RESCUE INC requires such training as a condition of adoption. I will submit proof of training from the trainer within 3 months of the adoption day or contact NEVADA FRENCHIE RESCUE Inc if I am unable to complete course in time.
5. I agree to license the Dog in compliance with the laws and ordinances in force in the municipality in which I reside. I agree that the Dog will wear an identification tag, which includes my name, current address, and phone number at all times, and to obtain a license for the Dog in the city or county in which I live. I also agree to immediately notify NEVADA FRENCHIE RESCUE INC in the event the Dog is lost or stolen.
6. I agree to notify NEVADA FRENCHIE RESCUE INC if at any time I can no longer keep the animal. If at a later date, I am unable or unwilling to keep the Dog, I agree to first contact NEVADA FRENCHIE RESCUE INC and allow NEVADA FRENCHIE RESCUE INC to reclaim the Dog at no charge to NEVADA FRENCHIE RESCUE INC.
7. I agree not to allow the animal to be used for medical or other experimental purposes, nor sell the animal to another party for any reason.
8. I understand and agree that the Dog is a rescue Dog and that Dogs respond to situations differently and unpredictably. I understand and agree that French Bulldog Rescue of makes no representations or warranties, express or implied, about the Dog's health, behavior or temperament. I understand that my adoption fee is not refundable after 72 hours from the adoption date.



9. NEVADA FRENCHIE RESCUE INC does not condone the use of electric shock collars. If you are having difficulty in training your new pet, you agree to contact NEVADA FRENCHIE RESCUE INC or DOG TRAINING BY PJ for assistance.

10. Adoptee will never be tied up on Adopter's property or elsewhere. Adopter understands that restraining a dog by tying it to a fixed post or wire is unsafe, even when Adoptee is supervised, and that it may cause unpredictable behavior and random aggression. If this clause is breached, NEVADA FRENCHIE RESCUE INC will immediately exercise its RIGHT TO RECLAIM, and Adopter will be required to pay liquidated damages in the amount of \$500 to offset the cost of any training or reconciliation required.
11. I further understand that I may have to give up custody of a stray animal if the rightful owner claims it within 30 days of the adoption.
12. I agree to allow a NEVADA FRENCHIE RESCUE INC representative, with prior notice, to visit the Dog and my home in the future for the purpose of determining compliance with the terms of this adoption agreement.
13. I agree to fully and completely release NEVADA FRENCHIE RESCUE INC, its officers, volunteers, agents, employees, contractors and representatives, from any liability of any kind whatsoever arising from any health or temperament issues the Dog may have or may develop, and/or from any and all claims relating to my adoption, ownership or possession of the Dog.
14. I agree to indemnify and hold harmless NEVADA FRENCHIE RESCUE INC, its officers, volunteers, agents, employees, contractors and representatives from any and all losses, fines, claims or damages, including reasonable attorneys' fees, arising out of or relating to my adoption, ownership or possession of the Dog, including and claims for injury or damage to persons or property caused by the Dog.
15. NEVADA FRENCHIE RESCUE INC INITIALS \_\_\_\_\_ ADOPTER(S) INITIALS \_\_\_\_\_ Adopter(s) understand that this animal is SPECIAL NEEDS DOG (IF INITIALED) which may require short or long term care and adopter promises to provide care that this special needs dog needs to become a functioning family member.

NEVADA FRENCHIE RESCUE INC INITIALS \_\_\_\_\_ ADOPTER(S) INITIALS \_\_\_\_\_ Adopter(s) understand that this animal is HAS BEEN SPAYED/NEUTERED / HAS NOT BEEN ALTERED SPAYED/NEUTERED (CIRCLE ONE) and AGREES to spay this dog within the time period advised by the adopters' veterinarian of choice, but in no case to allow this animal to remain unaltered or breed this dog in any manner. Any breeding of this dog will constitute an immediate BREACH OF CONTRACT and the dog will be confiscated by NEVADA FRENCHIE RESCUE INC. NEVADA FRENCHIE RESCUE INC will not condone breeding to create more burden on the over population of the dogs.
17. NEVADA FRENCHIE RESCUE INC reserves the right to confiscate this dog immediately and rescind the contract if the dog is NOT ALTERED WITHIN (15 DAYS) (30 DAYS) OF THE SIGNING OF THIS AGREEMENT. Any requests to change the alteration date must be made IN WRITING to NEVADA FRENCHIE RESCUE INC with an acknowledgment from NEVADA FRENCHIE RESCUE INC the request was received and granted.
18. I certify that all the information provided by me herein is true and correct. I agree to immediately relinquish the Dog to NEVADA FRENCHIE RESCUE INC, and surrender ownership of the Dog to NEVADA FRENCHIE RESCUE INC, upon demand, in the event that (1) any statement made by me are found to be false; (2) my check for the adoption fee is returned for insufficient funds and I do not immediately pay NEVADA FRENCHIE RESCUE INC the adoption fee and any banking fees incurred by NEVADA FRENCHIE RESCUE INC and/or (3) I fail to comply with the terms of this adoption agreement. I agree to pay and reimburse NEVADA FRENCHIE RESCUE INC for any and all legal fees and court costs NEVADA FRENCHIE RESCUE INC may incur in enforcing the terms and conditions of this adoption agreement. I certify that I am at least 18 years of age and fully understand the contractual obligations set forth above.



19. REMEDY FOR NON-COMPLIANCE: It is agreed that NEVADA FRENCHIE RESCUE INC retains superior Title of said animal, limited to and for the express purpose of assuring the animal's well being and will only exercise its superior claim in the event it appears to NEVADA FRENCHIE RESCUE INC that the proper and humane care as specified in the above adoption provisions is not being afforded said animal, in which case the animal may be taken through a Claim and Delivery proceeding. I have read this section. I have had it explained to me and I completely understand and accept the rights and obligations involved.
